#### **22/... Situation of human rights in the Islamic Republic of Iran**

*The Human Rights Council,*

*Guided* by the Charter of the United Nations, the Universal Declaration of Human Rights, the International Covenants on Human Rights and other relevant international human rights instruments,

*Recalling* Human Rights Council resolutions 16/9 of 24 March 2011 and 19/12 of 22 March 2012, General Assembly resolution 67/182 of 20 December 2012 and all previous resolutions of the General Assembly on the situation of human rights in the Islamic Republic of Iran, and regretting the lack of cooperation of the Islamic Republic of Iran with the requests of the Council and the Assembly made in those resolutions,

*Welcoming* the report and recommendations of the Special Rapporteur on the situation of human rights in the Islamic Republic of Iran submitted to the Human Rights Council,<sup>1</sup> and expressing serious concern at the developments noted in that report as well as the lack of access permitted to the Special Rapporteur to travel to the Islamic Republic of Iran,

*Recalling* Human Rights Council resolutions 5/1, on the institution-building of the Council, and 5/2, on the code of conduct for special procedures mandate holders of the Council, of 18 June 2007, and stressing that mandate holders are to discharge their duties in accordance with those resolutions and the annexes thereto,

1. *Decides* to extend the mandate of the Special Rapporteur on the situation of human rights in the Islamic Republic of Iran for a further period of one year, and requests the Special Rapporteur to submit reports on the implementation of his mandate to the Human Rights Council at its twenty-fifth session and to the General Assembly at its sixty-eighth session;
  2. *Calls upon* the Government of the Islamic Republic of Iran to cooperate fully with the Special Rapporteur and to permit access to visit the country as well as to provide all information necessary to allow the fulfilment of the mandate;
  3. *Requests* the Secretary-General to provide the Special Rapporteur with the resources necessary to fulfil the mandate.
