




FOREWORD



Introduction

The Organization for Defending Victims of Violence (ODVV) is a non-governmental, non-profit, non-political organization in Special Consultative Status to the Economic and Social Council of the United Nations (ECOSOC). The ODVV was established in 1988 in Tehran and has been active in the field of human rights and humanitarian activities. The ODVV is also associated to the United Nations Department of Public Information (UNDPI), a participatory of the NGOs Coalition for an International Court (based in New York), and member of the Global March Against Child Labour (based in New Delhi) which cooperated in a variety of issues with international organizations and has working relations with many NGOs in Iran and around the globe. The ODVV is also member of the Asia Youth Network, Conference of Non-Governmental Organizations (CONGO), and the International Movement for a Just World (JUST), and International Rehabilitation Council for Torture Victims (IRCT) and member of the Central Council, and AMAN Network of Middle East and North Africa Rehabilitation Centres for Torture Victims and first deputy of the Network.



ODVV Mission Statement

Through benefiting from experienced experts in its board of directors' structure and also the use of the expertise of close to 100 experts and volunteers in human rights, international law, international relations etc. the ODVV endeavours to through the combination of science and strategy to have the best effectivity in the field of nongovernmental human rights activities of the country. The following is a brief narration of the activities that the aforementioned departments conducted in 2017

Education and Research Projects and Activities

For the purpose of the production of presentable researches to scientific and official communities in the field of human rights with legal, economic, social and cultural subjects, through forming experienced expertise teams in the fields of demands of society, the ODVV conducts general or thematic researches in the form of various projects and researches. The conducted researches and studies in these projects, are basis for conducting practical projects such as education courses and workshops and scientific and educational settings. The following is a brief narration of the activities that the aforementioned departments conducted in 2017.

Education Workshops

Group Conversation Workshop on the Introduction to Human Rights Terminologies

On 9 December 2017, the ODVV held a series of group conversation workshops on the Introduction to Human Rights Terminologies to increase the technical knowledge international field experts for students and post-graduates and doctorates, at the ODVV conference hall. The aim in holding these series of workshops is the introduction of the participants to the technical texts of the field in English, introduction to technical terms, conversation in English in this regard and also strengthening their listening to technical literatures in English. One of the education contents which was used in these courses was the texts of Human Rights Council reports and resolutions and video clips of the Council Sessions. These workshops will continue into 2018.



Education Courses

First Comprehensive Education Course and Mock Human Rights Council Session Held



The First Comprehensive Education Course and Mock Human Rights Council Session was held by the ODVV and with the cooperation of UNIC and UNA-Iran. The two-month course began on 21 November and ended on 10 December. There were 43 post-graduates from the fields of international law, international relations, human rights, political science and political sociology that participated in this course.

Also on the final day of the course which was held on 10 December which coincided with Universal Human Rights Day, the UN Secretary-General's message for the day was read by the representative from UNIC in Iran.

In this course step by step important and operational procedures of the Human Rights Council that include introduction to the Human Rights Council and the role of states and NGOs, learning how to write statements, report writing and searching Human Rights Council documentation archives, cyber training on introduction to the Human Rights Council environment, thematic and country rapporteurs, Human Rights Council working agenda and mock Human Rights Council session, were taught by top tutors experienced in international relations. At the end of the course the participants received international certificates signed by the partner organizers.

Sittings

Technical Sitting on Terrorism, Extremism and Violence

This technical sitting was held on 3 May 2017 in the ODVV conference hall by the ODVV and with the participation of Niece University professor John Locke and the director of the Political and International Studies Centre of the Ministry of Foreign Affairs, and Deputy Foreign Minister, and former Iranian Ambassador the UN, Dr. Mohammad Kazem Sajadpour.

With regards to terrorism and extremism in the region, Dr. Sajadpour explained: "terrorists and individuals associated to extremist groups have a very low understanding of Islam and in most instances they do not have any ideas about this religion." He continued: "the nurturing of terrorists includes various levels that include, individual, social, regional and international." "Terror campaigns are a combination of ideology and practice, which is an ideology and belief as a result of some existing theories, and the function of these individuals are based on the beliefs of an organized organization." He added and went on to reassure that: "this factor in three dimensions determine numerous actors and unconventional acts, ideological



tools with regards of acts of terror and lack of foresight and also violent text of acts of terror in the Middle East."

The next speaker was Jean-Luc Vannier, psychoanalyst and Nice University Lecturer considered the explanation of the psychological dimensions of this issue, the trend to terror and extremist groups as the result of various reasons. He assured that: "Most people who suffer mental issues such as depression and distress, join terror groups to release from these disorders." This Nice University lecturer added: "The feeling of need to destroy because of the feeling of guilt by these people, in the event of failure to manage these feelings, will force these suffering individuals to destroy themselves and in the long run force them to destroy others by joining terror groups."

Dr Jean-Luc Vannier explained: "In a way with the merger of the thought to access peace and achieving advanced personality, and also to reach higher human status, extremist ideology draws humiliated individuals towards it. Also the luring of the thoughts of individuals who have the suitable base to accept these types of beliefs, is another instance that draws individuals towards extremist groups. The promise to control the whole world and also promises of matters which causes the uprising of individuals who have the right mentality to join extremist groups to reach their ideals, is another instance which causes the drawing of some individuals towards these groups."

At the end of this sitting, a Q&A session was held between the panel's experts and the audience. It must be said that an education workshop entitled, Education Workshop on Freudian Psychotherapy: from Theory to Practice in Therapy Session was held by the ODVV Rehabilitation Department and Dr. Jean-Luc Vannier as facilitator for 30 psychologists and psychotherapists.

Projects

Prevention of Domestic Violence and Life Skills Training Project

According to the tripartite agreement between the ODVV, UNHCR and BAFIA the Prevention of Domestic Violence and Life Skills Education Project began on in May 2017 and is due to finish in September.

This project has been designed for 80 Afghan refugees (40 men and 40 women) in the 12 to 59 age

group and with the aim of reducing social and mental abuse, increasing self-belief, and prevention of domestic violence among Afghans residing in the Varamin district.

Also in view of:

1—the need for this community to learn domestic violence prevention and reduction methods,
2—extensive positive response of refugees from previous conducted projects, and
3—the need to further expand these trainings to more vulnerable regions (such as Varamin; this project was designed. Based on the field visits and interviews that took place with the refugees and key Afghan community figures in Varamin, where the social and mental abuse levels – particularly domestic violence – are very high, which brings about irreversible consequences that include rise in addiction, suicides and various social damages. This same issue made the ODVV to pursue the holding of necessary training consecutively for the third consecutive year, for the refugee community in the Varamin and suburbs districts.

Also 80 direct beneficiaries of the project who will be trained as P2P in life skills and violence prevention methods, will each transfer what they have learned to 5 of their peers, which ultimately will see 400 Afghan refugees that are trained in the prevention and reduction of domestic violence.

Conferences

Participation in the National Conference on the Elimination of Violence against Women: Challenges and Solutions

The ODVV participated in the holding of the Elimination of Violence against Women; Challenges and Solutions National Conference that was held on 4 January 2017 in Shahid Beheshti University, hosted by the National Union of Bar Associations of the Justice Department.

Concept understanding and pathology and examples and extent of violence against women, violence from the criminal law and criminology aspects, violence from human rights and international documents aspects, violence from sociological and psychological aspects, violence from cultural and economic attitudes, methods for confronting violence against women, religious and legal concepts of elimination of violence against women and comparative study of violence against women and distribution and severity of forms of violence in the word were some of the subjects of debate and review by the experts and speakers of this conference.

Commemoration of International Days

Commemoration of the International Day for the Elimination of Violence against Women

On the occasion of the International Day for the Elimination of Violence against Women and with the cooperation of ODVV Raha Rehabilitation Centre, UNIC and Relief International,



on 25 November the ODVV held a series of educational sittings on a new perspective on intervention, prevention, reduction and treatment of gender based violence (GBV) "interview, diagnosis and treatment of GBV models" in a three-day education workshop with presentation of international certificates of attendance, on the occasion of the International Day of Non-violence.

The three-day workshop began with the reading of the UN Secretary General's message for the day by Mohammad Rajaee Moghadam, representative from UNIC in Iran. The participants included a number of jurists, lawyers, NGOs and human rights activists.

Support and emergency intervention methods for controlling violence, prevention of GBV methods, different types of violence, pathology of the meaning of violence and its related concepts, GVB creating social and cultural beliefs, psychological views on the definition of GBV, the connection between upbringing and parenting methods in relation with GBV, personality, mood and anxiety disorders in relation with GBV, preventative emergency intervention, were some of the important subjects of discussion of the first two days of the workshop which were discussed by Seyed Ahmadreza Salamat, the ODVV Rehabilitation Department Deputy.

Also the review of the most important prevention and treatment of the victims and perpetrators of GBV methods and case based intervention and with the help of practice and role playing were some of the important topics of the third day of the workshop which was discussed by Dr. Jaleh Afshari Monfared, the technical head of the Raha Rehabilitation Centre.



Commemoration of the international Day in Support of Torture Victims

The technical sitting in support of victims of torture was held on the occasion of the International Day in Support of Victims of Torture on 26 June at the conference hall of the ODVV and the presence of psychologists and psychotherapists and social workers, and with the aim of teaching interview and rehabilitation of torture victims techniques.

The training of therapists for helping victims of torture to return to normal lives and support counselling were some of the important education headings of this technical sitting. Also the facilitator of the workshop, Dr. Jaafari described the logical confronting of the past and acceptance of the present in two headings, in the treatment of torture victims and said, "For treating torture victims the cognitive therapy, behavioural and psychoanalytical methods can be used. Of course the best therapy is team therapy where as well as the therapist, there are also a social worker and psychiatrist present."



International Conferences and Coalitions

As a nongovernmental organization, the ODVV conducts part of its activities in the international arena, and by acquiring a special consultative status from ECOSOC the ODVV has managed to have the opportunity to participate in the former Commission on Human Rights and its substitute the Human Rights Council periodic sessions, and by issuing statements the ODVV presents its official positions. The ODVV also endeavours to by participating in international conferences to create new opportunities and capacities in the international scene.

The 10th Minorities Forum

The 10th Minorities Forum was held on 30 Nov-1 Dec 2017 at the UN Geneva Headquarters. The subjects of this Forum were to find solutions and recommendations for minority youths with regards to education, participation in public life, participation in the media in the digital era and the role of these youths in sustainable and stable peace building. There were four panels.

It must be said that the Minorities Forum has been created for the purpose of creating a centre for dialogue and cooperation in national, ethnic, religious and linguistic minorities' issues, and submission of thematic reports and technical consultation to the Special Rapporteur on Minorities issues. The ODVV tried in this Forum and previous year's Forum to have better cooperation with the Forum through preparing reports, writing and reading oral statements through various items.

Visit to Iraqi Rehabilitation Centres

Following the AMMAN Network sitting in the first week of May 2017 in Jordan with regards to launching a data bank for registration of information of cases who have been admitted to rehabilitation centres and the need for coordination between member centres of the region and benefiting from each other's experiences, representatives from the ODVV paid a visit to the Bahjat Al-Fuad Rehabilitation of Medical and Psychological Centre for Torture Victims (BFRCT-Basrah) and the WCHAN Organization for Victims of Human Rights Violations – Trauma Rehabilitation and Training Centre (Sulaimaniya) from 14 to 20 September 2017 in Iraq. The following were reviewed and discussed in these visits of the two centres:

Exchange of experiences, information and views of related fields and fields of interest, review of the daily activities and how services are provided in these centres, review of the referral to these centres system review of the possibility of conducting joint projects, drawing international cooperation and strengthening of initiative actions in the region.

It must be said that the ODVV signed two separate letters of understanding with these two centres.

Participation in the 36th Session of the Human Rights Council

The 36th Session of the Human Rights Council took place on 11-29 September 2017 at the UN European Headquarters in Geneva, Switzerland. The most important activities of the ODVV in this Session include:

- Organization of the participation of 6 Iranian NGOs in Consultative Status in the Session

As one of the most important human rights institutions in the international order, the Human Rights Council provides good opportunities for NGOs to have a platform and play a role; where often these opportunities turn into competitions between organizations. For this reason further benefiting from these opportunities is very important. Thus, one of the main activities of the ODVV in the 36th Session was the arranging the participation of 6 Iranian NGOs in Consultative Status. This activity was done in two stages: Tehran and Geneva, through which the following actions

were taken: identification of accompanying NGOs, their registration through the new Council system, registration for reading oral statements, and preparation of 12 oral statements and their reading at the Council Session.

- Preparation of Written Statements and their Submission and their Registration in the Council's Directory

One of the existing opportunities at the Human Rights Council for NGOs to play a role is the registration of written statements in the Council's directory which is possible via the Council website. Just as in oral statements, written statements must be prepared under the 10 items of the permanent working agenda of the Council; and be set according to the relevant standards. The ODVV prepared 5 written statements for this Session. The subjects of these statements were: the human rights situation in Palestinian Occupied Territories, necessity to pay attention to the growth of Islamophobia, unilateral coercive measures and human rights, US and British financial backing of the Saudi led coalition, and the situation of Afghan refugees in Iran.

- Preparation of Thematic Strategic Report and Handing in the Council Session

With the efforts of ODVV experts and through extensive studies, in this Session a thematic strategic report was prepared through consideration of priorities to the respect of human rights, and the domestic and international interests of the Islamic Republic of Iran:

■ “Sanctions tantamount to violation of human rights”

The issue of unilateral sanctions imposed against Iran has been one of the focal subjects of the ODVV in its research and executive activities. Thus, following a study of various fields related to the sanctions issue that include: the banking sector, medicines and treatment, industries, development and the economy, in this stage a report on the effects of sanctions on the medicine and treatment sector entitled “sanctions, tantamount to the blatant violation of human rights: thematic study of the effects of sanctions on the supplies of medicines in the Iranian society, was prepared. Attention to the fact that this report was getting prepared by a domestic NGO, the views of the general public, the experiences of manufacturers and importers of medicines and media information was utilised in preparation of the contents of the report. Considering the lack of sufficient statistical data in this regard, through documentation and analysis of existing data efforts were made to have the contents of the report be strong and persuasive. This, is the first issue of a series of ODVV productions regarding the “effects of sanctions on the people of Iran”, which is towards the production of scientific literature in the international language with regards to the human rights situation in Iran.

- Preparation of oral statements and their reading in the Session

In this stage, the ODVV in total, prepared 12 oral statements for general debates and interactive dialogues under working agenda items 3, 4 and 7 in consideration of concerns and priorities in human rights debates, which were read by 6 Iranian NGOs. Some of the topics raised in the oral statements were as follows:

The situation of refugees in Iran, unilateral coercive measures and the violation of the right to development, the killing of Rohingya Muslims in Myanmar Israel's settlement building in occupied territories, terrorism and Shiaophobia, child victims of armed conflicts, the situation of children deprived of education in Yemen, the effects of sanctions on scientific and technological advancements, effects of armed conflicts on the environment.

- Meeting with the Special Rapporteur on Unilateral Coercive Measures and his assistant

One of the main and significant things that the ODVV does during participation in Human Rights Council Sessions is arranging meetings with thematic and country rapporteurs. In this Session the ODVV managed to have a meeting with the UN Special Rapporteur on the negative impact of the unilateral coercive measures on the enjoyment of human rights and his assistant. While speaking about the effects of sanctions on the economic, social, cultural, and scientific and health conditions of society, in this meeting ways to promote mutual cooperation and also ways for NGOs to help the Special Rapporteur were discussed and reviewed. Also in this meeting a copy of the book "Sanctions: Tantamount to Violation of Human Rights" was presented to the Special Rapporteur.



- Holding Sidelines Panels


Holding sidelines panels is another available opportunities in the Human Rights Council which can be utilised through the expertise and experiences of experts in the field, and while drawing the attention of government officials and NGOs towards concerning issues, to exchange views,

reports and experiences of governments and participating NGOs in the Human Rights Council, and pave the way for future cooperation.

Thus, with the cooperation of a number of NGOs, the ODVV held 2 sidelines panels on the following subjects:

■ Human Rights in Yemen, Children and Cholera

The Human Rights in Yemen, Children and Cholera sidelines panel was held on 20 September 2017 by Kimia Organization and the partnership of the ODVV and INSAN Organization for Human Rights from Germany. In this sitting which was held on the sidelines of the 36th Session of the Human Rights Council in Room XVI, Yemeni human rights activist and lawyer and the director of Human Rights for Yemen Organization Ms. Kim Sharif resident in the UK, human rights activist Mr. Hassan Al-Wazir resident in Germany and Yemeni human rights activist and director of Human Organization Mr. Ayesh Al-Sandi, gave speeches.



■ Human Rights in Yemen, Human Crisis

The Human Rights in Yemen, A Human Crisis sidelines panel was held on 22 September 2017 by the ODVV and partnership of Insan für Menschenrechte und Frieden Organization. In this sitting British human rights activist Mr. Samuel Walton, human rights activist and the secretary general of Insan für Menschenrechte und Frieden Organization Mr. Abd-ol-Latif Al-Washli, and Yemeni human rights activist Dr. Abd-ol-Qader Al-Amdi resident in Germany gave speeches.

Through presentation of documents, each of the speakers established the dimensions of the dire human rights situation in Yemen. While mentioning statistics and evidence of the use of cluster ammunitions and weapons used by the Saudi led coalition that according to international conventions are prohibited, they also presented a report of the destruction levels of infrastructures and civilian casualties according to reports of UN Special Rapporteur, and also Amnesty International and Human Rights Watch. The speakers also reminded the responsibility of western governments that sell prohibited weapons to the Saudi government and the coalition forces in the worsening human rights situation in Yemen, and stressed on the role of civil society in whistle blowing on the sale of these weapons and guide public opinion to demand and put pressure on governments to stop the sale of illegal weapons. At the end while stating the importance of the prosecution of war crimes for using banned weapons, the speakers called for the setting up of an

independent international fact finding committee.


The head of ODVV's Geneva Office and doctorate in international relations from Geneva University, Mr. Hassan Fartousi was the moderator of this panel. Following asking the speakers some questions and receiving replies, while summing up Mr. Fartousi thanked the speakers, human rights activists, NGO representatives and a number of UN human rights experts and members of state delegates in the UN, members of parliament and the Special Rapporteur who were among the attendees of the panel.

- Preparation and Publication of Specific Media Product

With the aim of expanding its international links and making an impact in the Human Rights Council, through publication of media products and reports of its activities, the ODVV produces various items such as Defenders Newsletter, annual reports and multimedia CDs, joint statements with 30 Iranian NGOs on condemnation of the Myanmar government's actions against the Rohingya Muslims, joint letter with 700 Iranian and international journalists calling for the investigation of the Myanmar Muslims' conditions, all of which were extensively reflected in the 36th Session.

- Let Us Understand the Children of Yemen Photo Gallery

On 23 September 2017 a photo gallery entitled "Let Us Understand the Children of Yemen" was held in Geneva's city centre. This gallery which was held with the support of the ODVV and Yemeni human rights activists was open from 8am to 6pm. On display were various images of Yemeni children, the extensive destruction of schools, hospitals, and the spread of cholera and other devastations, which had a good public response of the locals and tourists. Through handing out brochures and also holding conversations, Yemeni human rights activists tried to send a message of the urgency for putting an end to the war in Yemen.



Human Rights Activists' Protests in Condemnation of the Tehran and London Terror Attacks Outside the UN in Geneva

On the initiative of ODVV Representative Office in Geneva and in condemnation of the terror attacks in Tehran and London, and also the Saudi led attacks against the innocent people of Yemen, on 15 June a protest was held outside the UN Headquarters in Geneva.

This demonstration was held at the same time as the 35th Session of the Human Rights Council and holding placards and chanting slogans the participants condemned the recent terror attacks. In separate brief speeches, human rights activists called for the efforts of the international community and human rights institutions to put an end to these inhuman actions. In their speeches these human rights activists condemned the Tehran and London terror attacks and also the Saudi led attacks on Yemen and declared their support for the people of Yemen.



Participation in the 35th Session of the Human Rights Council

The 35th Session of the Human Rights Council took place from 13 June to 1 July 2017 under 10 items of the working agenda at the UN European Headquarters in Geneva. Just as in the past, ODVV representatives in Geneva through extensive effective efforts, to make use of all opportunities to accomplish its objectives in the international arena. The activities of the ODVV in this Session included the preparation of 6 oral statements holding 2 sidelines panels on the human rights situation in Yemen and distribution of ODVV products in the Council.



Practical Workshop on the Launching of Data Bank for the Registration of Cases in Rehabilitation Centres

To bring cohesion to victims of torture and violence related data, and also providing assistance to centres active in the field, IRCT through a global project has taken steps to prepare and design a data bank entitled Data in the Fight Against Impunity, for the purpose of registration of the information of cases that have gone to these centres. This workshop was held from 3 to 6 May 2017 in Amman the capital of Jordan with the aim of participation for the fight against impunity through the collection of necessary data from torture victims and towards the accountability, prevention and treatment of these individuals. Participating in this meeting were centres from Iraq, Iran (ODVV), Jordan, Palestine, Lebanon and Morocco. Also the special objective of this project is the strengthening and coordination of the capacities of rehabilitation centres to collect clinical psychological data and the use of the results and outputs for human rights activities and fight against impunity. This data bank has been launched with the cooperation of various centres from the abovementioned countries, and recently its second version which has corrected the problems of the first version have been launched in the centres of these countries and are being used. The IRCT's programme is to bring about conditions where all its members benefit from this data bank.

Participation in the 34th Session of the Human Rights Council

The 34th Session of the Human Rights Council took place from 7 February till 24 March 2017 in Palais de Nations in Geneva. Some of the important actions of the ODVV in this Session include:

- The Empowerment of 17 NGOs in Consultative Status to ECOSOC: "Effective Participation in the 34th Session of the Human Rights Council"


One of the main activities of the ODVV in the 34th Session of the Human Rights Council was the arranging of the effective participation of Iranian NGOs in Consultative Status to ECOSOC in the 34th Session of the Human Rights Council.

This activity took place in two stages, one in Tehran and the second one in Geneva. In the first stage necessary trainings were given to representatives of 17 NGOs followed by the drafting of a plan of action by the ODVV. In the second stage too in Geneva while holding coordination meetings, the actions planned in Tehran well put into effect.



- Preparation of Written Statements and their Registration in the Council Directory

The ODVV prepared 7 written statements under the 10 permanent working agenda of the Council, with consideration of relevant standards. These statements were mostly on the subjects of violation of women and children's rights in armed conflicts in the Middle East, the refugee crisis, environmental catastrophes, Islamophobia, the effects of sanctions on societies, right to education etc.



- Preparation of Thematic Strategic Reports and their Publication at the Council


In this Session with the guidance of ODVV experts and through coordination meetings, 21 thematic strategic reports with consideration of priorities to respecting human rights were compiled. The refugee crisis, water crisis, violation of the rights of people with disabilities, spread of



Islamophobia etc were some of the subjects of these reports which were compiled, designed and printed and were distributed in large quantities at the Human Rights Council. Some of the reports were as follows: War and mental health in the Middle East; The necessity to pay attention to human rights principles in international policies on climate change; environmental crimes and human rights; violence and human rights violations; the violation of the rights of people with disabilities in regional conflicts; the repercussions of sanctions and their effects on civil society; children deprived of education in regional conflicts; review of women's situation in the Middle East region in the last decade from the human rights aspects; child victims of terrorism.

- Preparation of Oral Statements and Reading them at the Council with a Concentration of the Subjects of the Special Rapporteur on Iran and Middle East issue

In this stage the ODVV prepared 8 oral statements in total for the general debates and interactive dialogue under the working agenda items 3, 4, 5, 6, 7, and 9. Also approximately 31 statements were prepared under the supervision of ODVV experts. Some of the subjects of the ODVV and other NGOs oral statements were as follows: violation of children's rights in the Syrian conflict; the effects of unjust sanctions on the economic, social and health situations in Iran; threats to the environment in the Middle East conflicts; violation of women's rights in Middle East conflicts (trafficking and sexual exploitation); consequences of forced repatriation of refugees on children, negative consequences of armed conflict on children in Syria, Iraq, Yemen, Bahrain and Palestine; the necessity to prepare a protocol or additional protocol to the Convention on the Rights of the Child for the improvement of refugee children's rights; condemnation of the entry into the United States ban on 7 Muslim majority countries.



- Arranging a Meeting with Asma Jahangir the UN Special Rapporteur on the Human Rights Situation in Iran

One of the main and important activities of the ODVV during its participation in the Human Rights Council Sessions is having meetings and technical sittings with thematic and country special rapporteurs, one of the important ones of which is meeting the Special Rapporteur on the Human Rights Situation in Iran. This meeting was of particular importance, in which Ms. Jahangir compiled

and submitted her report for the first time in her new position. Therefore, meeting and interaction of Iranian NGOs and raising issues and matters took place for the first time.

This meeting which took place on Sunday 12 March 2017, one day before the submission of the Special Rapporteur's report to the Human Rights Council and planned following the continued and difficult coordination of the ODVV. It must be said that the time foreseen for the meeting was an hour which increased to two hours due to the dynamicity of the subjects of discussion.

A number of main pivotal points were discussed in this meeting which included: the necessity for the Special Rapporteur to deal with the consequences of sanctions on economic, social, cultural, health and education rights, advances achieved with regards to women's rights that include the Diah, inheritance, promotion of women's presence in the education environments, reduction in underage marriages, and amendment of the drug offenders capital punishment law in her report.

- Holding the "Portal Towards Iran" Exhibit

At the same time as the 34th Session of the Human Rights Council, the ODVV held an exhibit on Nations Square in front of the UN Headquarters in Geneva, entitled, "A Portal Towards Iran". This exhibit was held with the aim of the reproduction of the concept of peace and rejection of extremism and violence by Iranians, in a unique and effective way. The details of the exhibit are as follows:



■ i) Photo Gallery

In this Exhibit 25 photos taken by Iranian janbaz (veteran) of the Iran-Iraq War, Davoud Ameri were on display with the subjects of Iran's nature, victims of war in Iran, and women and children in Iran. These pictures showed a different and attractive image of Iran for the European audience and was welcomed by visitors, to such an extent that in some instances they wanted to purchase the works of art.



■ ii) Displaying the Nowrouz 7 Cin Spread

In view of the 34th Session being held close to the Nowrouz (Iranian New Year) and the International Day of Happiness, it was a good excuse for the ODVV while setting the traditional Iranian 7 Cin spread, to also welcome spring and wish the visitors of the exhibit a Happy Iranian New Year. This move was made with the aim of introducing Iranian culture and classic traditions and also present a good image of the Iranian history and civilisation and change the perception of the European public impression of Iran.



■ iii) Introduction of Iranian NGOs

Participating in the Council Session, 17 Iranian NGOs introduced their organizations through participating in the “A Portal Towards Iran” exhibit. They did this through handing out brochures, books and reports of their annual activities and thematic reports. These products were on display for the visitors in two tents. Also banners with rejection of extremism and violence, friendship and kindness slogans were put up in different corners of the tents to send the message of the exhibit holders to the audience and passers-by.



■ iv) Playing Classic Iranian Music

Alongside the photo gallery, presentation of NGOs' reports, and setting up the 7 Cin display, and to complete and make a further impact of these activities, this year the playing of Iranian music was put in the to-do list of the exhibit, and classic Iranian music (often with no lyrics) was played in the background for the visitors.

■ v) Holding the “Art for Peace” Exhibit

Following the successful experience of the ODVV in holding field exhibit of Iranian NGOs in Consultative Status to ECOSOC in the years 2015, 2016, and 2017, for the first time the “Art for Peace” exhibit was set up inside the main European Headquarters of the UN through the cooperation of the ODVV and three NGOs from 7 to 17 March. In this exhibit around 30 pieces of Iranian artists were put on display with the peace theme, which was extensively received by the audience.

- Meeting with Thematic Rapporteur

■ i) Meeting with Special Rapporteur on Rights of the Child

The Human Rights Council is a golden opportunity for interaction and dialogue with thematic rapporteurs. For this reason on 9 March 2017, a meeting was held with the UN Special Rapporteur on the Rights of the Child, Ms. Maud de Boer-Buquicchio in Wilson Palace by the Child Foundation and the ODVV and a number of NGOs.

In this meeting the subjects of discussion included the increasing of the legal age of marriage for girls law, further interaction with Iranian NGOs, and the Special Rapporteur's work methods were discussed. At the end brochures, thematic reports and business cards of NGOs were presented to the Special Rapporteur for further future communications.



- Holding Sidelines Panels

Holding sidelines panels is another of the available opportunities in the Human Rights Council which through the use of expertise and experiences experts in the field, benefit from these opportunities in the best way.

■ i) The Refugee Crisis and Violation of Children's Rights

This panel was held with the cooperation of the Child Foundation and UNICEF on 13 March and the speakers included Ms. Sarah Crowe UNICEF spokesperson on Crisis Issues in the Geneva Office, Ms. Taraneh Fathalian from Imam Ali Charity Population, Dr. Peyman Raoofi the executive director of the Child Foundation and Dr. Mostafa Mohammadi researcher from Lausanne University.

The speakers spoke about refugee host countries who have amended their domestic laws so that further protection is given to children. Also it was pointed out that the European Parliament has



passed legislation in protection of refugee and legal migrant children. But Hungary has refrained from taking similar measures and it is regrettable that the Hungarians who themselves experienced displacement during the Second World War, should provide more assistance to refugees. Also in this panel it was stated that the Convention on the Rights of the Child is an international covenant which has the most number of signatories, but the United States has refrained from signing this Convention.



■ ii) Yemen: 700 Days of Crisis and Criminals' Impunity

The "Yemen: 700 Days of Crisis and Criminals' Impunity" sitting was held on 15 March 2017 by the ODVV. The speakers of the sitting included, jurists Dr. Kim Sharif, Mr. Abdol-Latif Al-Washli, Mr. Ayesh Al-Sandi and Yemeni human rights activist Ms. Amal Al-Ma'Khazi.




The subjects that were discussed included: lack of access to clean water in Yemen, increase in cost of drinking water to 12 dollars per litre, destruction of 50 percent of the water supply infrastructure of Saana as a result of Saudi airstrikes, the siege of the airport and shortage of



medicines, airstrikes on strategic locations and oilfields, UN not active in Yemen, targeting Yemeni women and children in medical centres, not enough food for 7 million Yemenis, presentation of a report on casualty figures of 120,000 killed and more than 20,000 wounded in Yemen.

- Publication and Distribution of Specific Books, Journals, Annual Reports and Multimedia Products

With the aim of expanding its international links and making an impact in the Human Rights Council, through publication of media products and reports of its activities, the ODVV produced various items such as Defenders Newsletter, annual reports and multimedia CDs and extensively distributed them in the 34th Session of the Human Rights Council and the exhibits that were held.



- Active Participation of ODVV Experts in other NGOs Sidelines Panels

One of the significant actions of the ODVV in this Session was the active participation of its experts in the sidelines panels. Towards this action, the table of the sidelines panels were studied and the some of these panels which were more in line with the work field of the ODVV were selected and from a pre-planned programme, the experts took part in these panels and prepared full reports.

Rehabilitation Department: Raha Counselling Centre



With a wish to mend and end mankind's pains and sufferings, and expansion of humanitarian campaigns, the ODVV Rehabilitation Department provides advisory and educational services. For the protection of victims of domestic and social violence, the department presents counselling and therapy in legal, family, marriage, psychological disorders at the Rehabilitation Centre . With the cooperation of 40 mental health experts and lawyers the Centre provides pre-marriage, education and legal counselling. The statistics of the cases is determined on the basis of gender, age, occupation, marital status, education levels and the reason for coming to the Centre. The ODVV uses the results of the statistics to set appropriate programmes and projects. In 2017, 3962 cases benefited from the Centre's services. 2050 of them were women and 1912 were men. According to the statistics most of the cases were married and the majority of them had family problems.

The Raha Counselling Centre also provides telephone hotline counselling services for psychological, marital, family and education issues via telephone hotline.

The monthly statistics for the hotline cases are worked out through variables such as, gender, occupation, age, marital status, education, and reason for call. In 2017, 1240 people benefited from the telephone hotline services, 857 women and 386 men. According to statistics the majority of cases had family problems. As an active member of the Employment and Education Committee the ODVV Rehabilitation Centre, has always endeavoured to work towards the prevention of violence in the "Prevention of Domestic Violence Document."

For the realisation of the goals of this Committee, by participation in all meetings with a description of practical activities in this regard, the Rehabilitation Department has undertaken a number of important measures, the important ones of which are:

- Identification of victims of violence at the Raha Rehabilitation Centre
- Review of effective approaches in counselling and psychotherapy in prevention of violence.
- Identification of suitable titles for technical sittings on prevention of violence and treatment of the victims, to hold at the Raha Rehabilitation Centre.
- Setting a suitable research method to review the link between violence and impractical schemas, depression and anxiety among victims of violence cases.
- Identification of counselling problems of related governmental departments with the Rehabilitation Centre project for treatment intervention and counselling towards increasing the mental health of target group.

Memory and Learning Education Workshop

The education workshop on Memory and Learning was held by the ODVV Rehabilitation Department on 18 December 2017 for 40 psychology and counselling students and post-graduates. The facilitator of the workshop was Dr. Mansooreh Fazilati, Shahid Beheshti University lecturer. The aim of this workshop was to further understand the brain as one of the most complex organs of the body in learning and memorising information.

The power of learning, the superiority of mankind to other creatures, the physiology of learning and memory, review of the neurological processes in learning, decoding, memorising what's been learned, the time the information is kept, recovery, remembering recorded information, memory stages, types of memory that include feeling short and long term memory, capacity of memory etc. were some of the points that were taught in this workshop.



Workshop on Training of Prevention of Verbal Abuse Trainers

The Workshop on Training of Prevention of Verbal Abuse Trainers was held on Saturday 2 December 2017 for NGOs and the members of the Health and Socio-psychological Population, with the cooperation of the ODVV and the Popular Preventions and Social Participations General Office of the Judiciary. The tutor of this technical workshop was



Dr. Shahrbanoo Ghahari and it was held with the aim of empowerment of NGOs and members of the National Mental Health Population for preventive intervention on the subject of violence and help the victims of violence. The workshop was held in the Social Deputy Assembly Hall of the Judiciary.

Determination of the definition of violence, the recommendations of the World Health Organization for the prevention of social damages, theoretic methods for the prevention of violence based on psychological approaches, establishment of the boundaries of disorders in the victims and perpetrators of violence with rages based on lac of skills, and intervention techniques for the reduction of damages caused by rage were some of the important subjects of this one day workshop.

Education Workshop on the Prevention of Abuse that Leads to Altercation

The Prevention of Abuse that Leads to Altercation workshop was held with the cooperation and tutoring of ODVV experts and by the Popular Preventions and Social Participations General Office of the Judiciary for lawyers and experts from the Judiciary, justice department experts, NGOs and religious leaders from 20 to 25 November 2017 in the city of Mashhad. Fundamental skills related to the subject of violence education, social facilitation for getting skills for social oriented interventions to utilise popular potentials to prevent physical, mental, sexual and economic abuse were the most important subjects of this training course which were taught over four days to two groups of 35 individuals. In the opening and closing ceremonies of the workshop, officials from the Tehran and Astan Khorasan Razavi Judiciary were present as guest speakers.



Workshop on Effective Communications Skills

This workshop was held by the ODVV Rehabilitation Department on 17 October 2017 for 45 experts and psychologists in the ODVV conference hall. In this 6 hour workshop Dr. Mansooreh Fazilati Shahid Beheshti University lecturer spoke about communication and what makes communication effective.

In this workshop at first the ten life skills, importance and necessity for teaching them to prevent social damages were discussed. This was followed by debate and exchange of views on the definition of communication and elements of effective communication.



Education Workshop on Freudian Psychotherapy: from Theory to Practice in Therapy

The one-day Education Workshop on Freudian Psychotherapy: from Theory to Practice in Therapy Session was held on 9 May, 2017 in the conference hall of the ODVV.

This one-day workshop that was entitled the “psychoanalytical approach for improvement through dialogue in various pathologies, was held with the presence of Jean-Luc Vernier, psychotherapist and Nice University professor and 30 psychiatrists, psychotherapists and psychologists.

The following topics were taught comprehensively and in detail to the audience:

- 1 – To explain the consequences of the discovery by Sigmund Freud of the primacy of the radical otherness in the creation of the unconscious and that of the human sexuality;
- 2 – studying through the historical background of psychoanalysis, the major concepts, always referring to the clinical basis;
- 3 – A thorough understanding of psychoanalysis and psychology in order to better assess the functioning of the human psyche, its desire, its identity and its place in the social group; and
- 4 – To give clinicians many efficient means in their daily work.

Also the participants of this workshop were introduced to discussions such as: a method of treatment of the neurotic disorders, presentation and exegesis of the psychoanalysis, from early childhood to adolescence, the cataclysm of puberty and the various adolescent addictions, a process of investigation of the psychic processes, the basic rules of the analytic session, conditions for the commencing of therapy session, The Freudian “setting”: from the face to face to the sofa. How? Why?, The differences between psychiatry, psychology and psychoanalysis, the fundamental situation of anthropology according to professor John Le Planch theory, trauma, sudden developments, and various addictions among youths, physical comfort.




Free Counselling Services for the Victims of the Plasco Building Disaster

The Raha Counselling Centre also in 2017 had the following activities in its working agenda:


- Increasing the number of the Centre's Telegram membership from 430 to almost 700 and posting materials daily on the application.

Statistics of Telephone Hotline Calls for 2017: 1240




Research and Publications

In view of its objectives and functions, the ODVV Research Department has produced various publications. The reflection of ODVV's activities as a nongovernmental organization in international conferences and gatherings can be seen as a positive performance in playing an active human rights role.

Thematic Reports

- Preparation of Thematic Reports for the 34th Session of the Human Rights Council

The ODVV Research Department prepared 21 thematic strategic reports by considering priorities for respecting human rights and distributed them at the 34th Session of the Human Rights Council.



Written and Oral Statements

- Written statements for the 36th Session of the Human Rights Council

To make use of existing opportunities at the Human Rights Council for NGOs to play a role, the ODVV prepared 5 written statements and registered them in the Council directory.

- Oral statements for the 36th Session of the Human Rights Council

With consideration of the human rights debates priorities, the ODVV prepared 12 oral statements for the 36th Session of the Human Rights Council to read at the floor of the Session.

- Preparation and Publication of Iranian NGOs' Statements on Myanmar

At the same time as the 36th Session of the Human Rights Council and to condemn the terrible events in Myanmar the ODVV along with more than 30 Iranian NGOs wrote a statement while

condemning the killing of Muslims in Myanmar for international human rights bodies to investigate the conditions of these people.

- Written statements for the 34th Session of the Human Rights Council

The ODVV prepared its written statements for the 34th Session of the Human Rights Council in view of the Council's set standards.



- Oral statements for the 34th Session of the Human Rights Council

The preparation of oral statements were done by the Research Department experts and their reading at the floor of the Session were some of the other activities of the ODVV.



Drafting and Preparation of Letter

- Joint Action of the ODVV with 700 Journalists in Condemnation of the Terrible Events in Myanmar

In a joint action, on 9 September 2017, the ODVV Research Department and more than 700 national and international journalists issued a letter addressed to the Human Rights Council calling for the international community to investigate the killing of Muslims in Myanmar. This letter and a list of its signatories was presented to the members of the Special Mandate International Fact Finding Group on Myanmar following the Human Rights Council meeting on Myanmar. Also the ODVV pointed out the journalists concern on Myanmar and called for the UN High Commissioner for Human Rights to investigate the brutal killing of Myanmar Muslims.

Publications and Books


- Defenders Newsletter Summer 2017

This edition of Defenders was published in 56 pages with an overhaul of the structure, content and form of the newsletter and bringing it closer to frameworks of a quarterly. The subjects covered by this edition include: the refugee crisis and the EU, systematic violation of human rights in Saudi Arabia, the link between peace and tourism, arms trade and violation of human rights, and a collection of articles by ODVV experts and volunteers.



- Preparation and Publication of the First Booklet in a Series of Books on Unilateral Sanctions

The ODVV prepared and published the booklet on “Sanctions: Tantamount to Blatant Violation of Human Rights” in 200 copies. This booklet was sent to 66 foreign embassies in Tehran. Also on the sidelines of the 36th Session of the Human Rights Council, the digital file of the booklet was sent to all Permanent State Representatives in Geneva, and 80 hard copies were distributed in the Council Session.



- Defenders Newsletter Autumn 2016 – Winter 2017

This issue of Defenders was published by the ODVV in 48 pages and with a concentration on human rights, citizen's rights, children, NGOs, the United Nations, and the UPR. This newsletter reviews various notable current subjects and issues of the world. Subjects such as the capacity of NGOs in Consultative Status in the UN, a look at human rights double standards in the international order, children's police and the necessity to set up a children's police unit in Iran, children's human rights situation, Syria and human rights challenges, Donald Trump and human rights, a look at the subject of ethnicity in Iran, Kurdistan a land of traditions, ancients customs and traditions, ODVV's active participation in the UPR, ways to promote human rights in Iran, Citizen's Rights Charter and independent media and an approach to the structure and nature of Citizen's Rights Charter in Iran.



Organization and Updating of the Library

The ODVV is equipped with a specialist library which contains books in Farsi and English. Also in 2017, with purchasing of dozens of new books on human rights and refining of the library and introduction of 2 books from the library in ODVV's Telegram, the the use of booklets, existing researches and articles, ODVV has facilitated the necessary conditions for honorary members, volunteers, researchers and students access for their studies and work.



Communications Department



For the purpose of increasing the capacity of the ODVV in its international links and making more impact on information dissemination, the Communications Department conducts various activities through the utilisation of the capacities of ODVV experts and effective presence in social networks.

Coordination and Publication the Contents of Websites and Social Networks

Information dissemination is another one of ODVV's activities towards its objectives. The ODVV uses various tools to achieve this.

- Farsi, English and Arabic Websites

The worldwide web is one of the necessary communications channel to access the audience. To benefit from this the ODVV has a trilingual website – Farsi, English and Arabic – (and the Arabic site was launched from the beginning of 2016). The ODVV has managed to make human rights news and development, its activities and positions towards various issues, its advancements throughout the year, objectives and programmes available to the addressees and keep them updated on a daily basis; in such way that in 2017, a total of 270 articles and around 1030 various news items on human rights issues were published on the three websites for interested parties to read.





- Editorial Board

The ODVV Editorial Board holds regular and organized meetings with a specific working agenda on a monthly basis for the purpose of promoting the activities of the websites and social networks and further communication with the audience through publication of news, articles and activities of the ODVV; with the participation of members and experts.

- ODVV Social Media Accounts

For the purpose of strengthening the links of the ODVV with sister international organizations and other addressees, the ODVV is active in Facebook, Twitter and Aparat. This action is with the aim of the utilisation of new communications tools, identification and creation of networks of institutes and human rights activists to show the existence of multiple voices from Iran on human rights, and information dissemination of activities and drawing further partnerships. These pages in the following address in 2017 published more than 1300 various human rights materials and articles.



Production and Publication

- *Launching ODVV's Official Telegram Channel entitled Human Rights Studies*

The Human Rights Studies Telegram Channel has been launched by the ODVV and with the aim of raising the awareness of the addressees on human rights scientific procedures and development. Until the end of January 2018 the Telegram Channel gained 520 members and the uploading of materials on a daily basis on human rights is the communications arm of the ODVV with addressees, volunteers and honorary members and has a practical approach. This Channel alongside the ODVV Volunteers Group Telegram account is launched and run by the volunteers group.



- *Launching the Data Bank of Documents and Reports of Human Rights Situation in Iran*

Through the designing and launching a data bank of documents, resolutions, reports and all important human rights treaties, the ODVV has facilitated the possibility of searching for reference sources and preparation of all its written and oral statements from the first Human Rights Council Session of the year to-date which include 157 oral and 149 written statements.
